

2020 Troop 22 Christmas Wreath Fundraiser Sale

Wreath Price \$20.00

Due to Covid Pandemic Restrictions some items are subject to change.

This is important information for all Scouts and Parents about our Christmas Wreath Fundraiser sale. This is one of various fundraisers that we have to raise funds to pay for all Troop expenses such as Campouts, equipment and help pay for Summer Camp and Year End Trip. This fundraiser has 2 mandatory participation requirements for each Scout which are as follows.

Requirement 1 - Each Scout is required to sell at least **12 Wreaths** independently (Personal Sales). We do encourage scouts to sell more than just the required 12 as there is a wonderful benefit. For every wreath sold above 12 the Scouts will earn a \$2.00 Scout account credit for each one sold. For example if he sells 36 wreaths he will earn \$48.00 into his Scout account. There are prizes in the form of Gift cards awarded to the top 3 Scouts who sell the most above the required 12.

Requirement 2 - Each Scout must participate in the Wreath Sales at St. Thomas Church Masses. He has to serve at least **3 Masses**. The 3 masses can be done all in one day or on separate days as per availability on schedule which will be available for Sign-up on November 3. Dates for sales are as shown on Troop Calendar.

Failure to complete these requirements has consequences.

We do a Pre-Order sale for the wreaths also, which we encourage you to participate. The order form and a sales flier are attached as PDF files which you can print out, you can also find them on the Troop website.

This Pre- Order sale has proven useful because when you are selling popcorn you can already mention the Wreath Fundraiser Sale to family and friends and neighbors. You can use the Pre-Order form to keep track of who you are taking orders from, what color bow they prefer (Red or Burgundy) and for keeping track of payments received. This way you can get them to buy from you well before they buy from a store. If you do sell wreaths on Pre-Order please submit a copy of the forms to me no later than October 31 meeting so that I can have an idea on how sales are going and to make sure that we will have enough supplies (Keep the Original for yourself).

Payments for wreaths can be made in cash or checks made out to BSA Troop 22. If you receive payments for wreaths you can turn them in to me at Troop meetings so that they can be credited to your sales. If at all possible, please get separate payments for popcorn and wreaths as this will make it easier to track, if not please make sure to let us know that both payments are being submitted together. All Payments for wreaths are to be placed in an envelope with Scout's full name and how many wreaths are being paid for written on it. This is very important in order to avoid confusion when crediting payments. Wreath Payments are to be turned in by no later than **January 12, 2020**. NO Scout will have money credited for their extra sales into their Scout Accounts until all payments are collected.

Scouts/Parents plan on attending the meeting on November 24. This is the day that Scouts decorate wreaths for the sales at the Masses. Parents plan on coming in to this meeting to pick up wreaths and supplies to decorate for your Personal sales. We have to leave the Gym at 9:00 pm, so if you do not get your supplies during the meeting then you will have to make arrangements to pick them up during the week or wait till the next meeting. I will possibly have supplies available for pick up at the meeting on November 17, I will notify everybody if that is the case.
